

## Legal & Privacy Notice

### 1. Introduction

Sundrift Games, LLC (“we”, “us”, or “our”) operates the website <https://sundriftgames.com> (the “Site”).

This Legal & Privacy Notice explains how we collect, use, store, and protect your personal data when you access or use our Site, as well as your rights in relation to that data.

### 2. Information We Collect

We may collect and process the following categories of personal data:

- **Technical & Usage Data:** Your IP address, browser type and version, time zone, device information, operating system, referring website, pages visited, time spent on pages, click behavior.
- **Contact Data:** If you contact us via email, form, or provide your details (name, email address, etc.), we collect that information.
- **Optional Data:** If you subscribe to newsletters or opt-in for communications, we may keep records of your preferences.

### 3. How We Use Your Information

We may use your personal data for the following purposes:

- To operate, maintain, and enhance the Site.
- To respond to inquiries, requests, or other communications that you initiate.
- To analyze usage patterns to improve functionality, content, and user experience.
- To comply with legal obligations, detect fraud, and protect our rights.

### 4. Legal Basis for Processing (if applicable under GDPR or similar law)

When required by law, we rely on one or more of the following legal bases:

- Your consent, when you opt in to certain services or communications.
- Performance of a contract or preparation to enter a contract.
- Legitimate interests: such as improving our services, ensuring security, and preventing misuse of our Site.
- Compliance with legal obligations.

### 5. Cookies & Similar Technologies

We may use cookies, web beacons, analytics tools, or similar technologies to:

- Distinguish you from other users for security and support purposes.
- Collect usage data and analyze traffic.
- Enhance and personalize your experience.

You have the option to disable or restrict cookies via your browser settings. However, disabling some cookies may affect functionality of the Site.

### 6. Data Sharing & Disclosure

We do not sell or rent your personal data to third parties. We may share information with:

- **Service Providers:** Providers of hosting, email delivery, analytics, etc., who assist us in operating the Site.
- **Law Enforcement / Legal Duties:** If required by law, or to enforce our legal rights.
- **Business Transfers:** In the event of a merger, acquisition, or sale of assets, personal data may be transferred under confidential terms.

## **7. Data Security & Retention**

- We implement reasonable technical, administrative, and physical safeguards to protect your personal data against unauthorized access, loss, alteration, or disclosure.
- Although we make reasonable efforts to safeguard your data, please be aware that no security measure is perfect or impenetrable.
- We retain personal data only as long as necessary for the purposes set out in this Notice or as required by law.

## **8. Your Rights**

Depending on your location, you may have the following rights:

- The right to access the personal data we hold about you.
- The right to request correction or deletion of your data.
- The right to object to or restrict certain processing of your data.
- The right to data portability where applicable.
- The right to withdraw consent, if processing is based on consent.
- The right to lodge a complaint with a supervisory authority.
